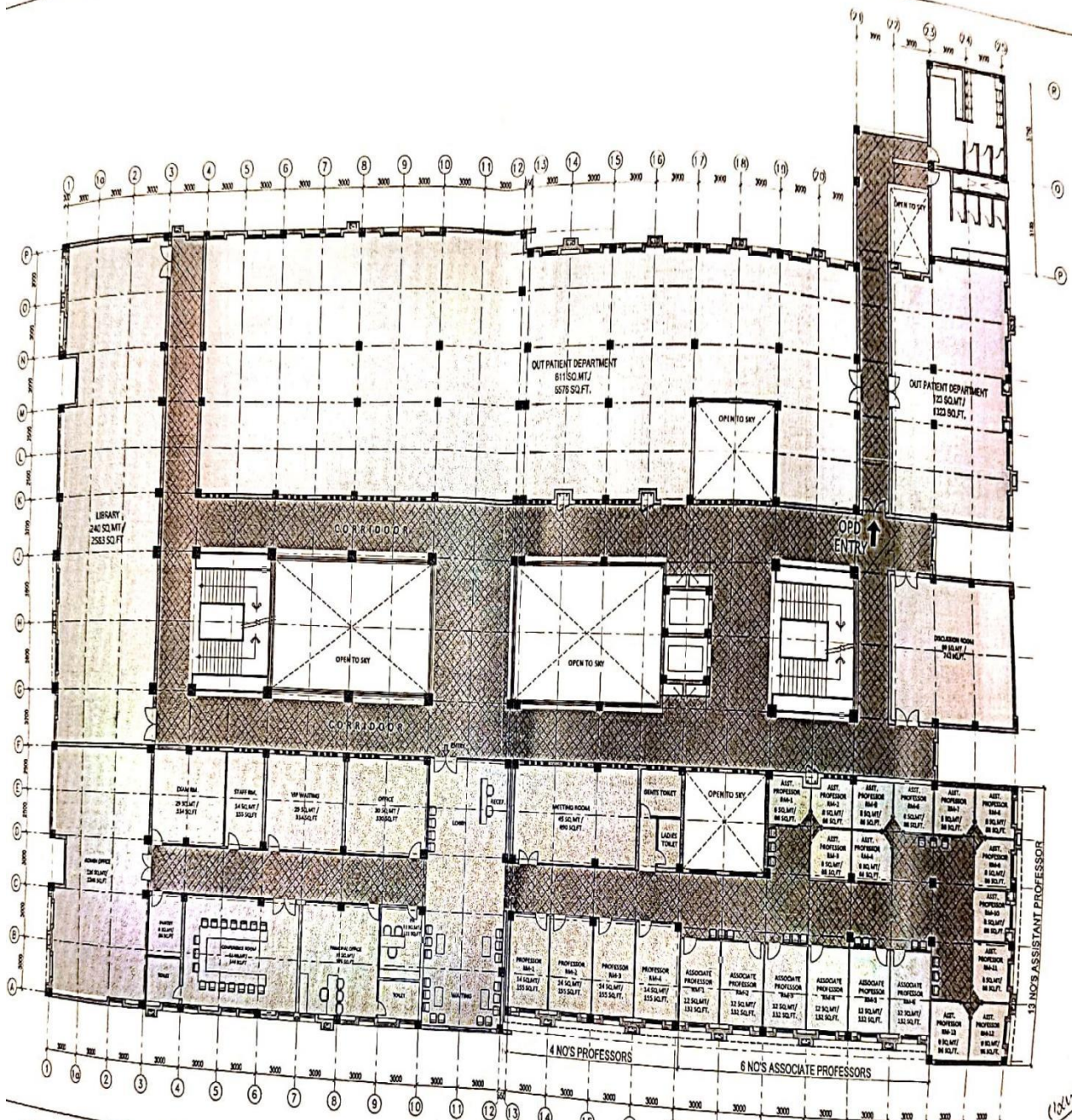


STRATEGIC PLAN DOCUMENTS
