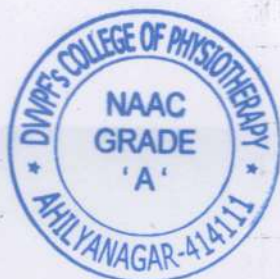

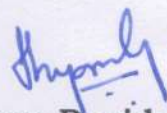
Statutory Declaration under the RTI act 2005
