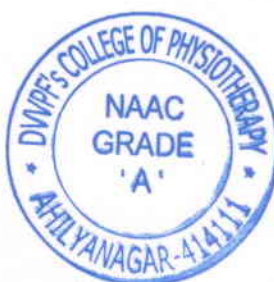

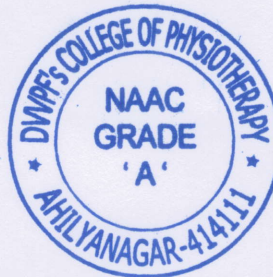

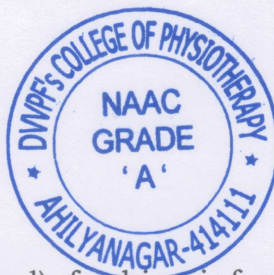
### **WOMEN DEVELOPMENT CELL (WDC) COMMITTEE**
